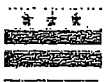

We would like to congratulate you on incorporation or authorization of your company in the District of Columbia. This process establishes the legal creation or gives authority of the entity to conduct business within the District of Columbia, but does not license the company's activity, issue the permit or register for taxation purposes.

**It is your responsibility to ensure compliance in those areas.**

Every domestic and foreign corporation and LLC is required to file two-year report to maintain good standing within the District of Columbia.

Please, check the information listed below to determine your company's 2-year report requirements:

- 1 **Business Corporations** inclusive of domestic or foreign business, professional or close corporations that register **on or before April 15<sup>th</sup> of any given year must file a two-year report by April 15 that same year and every two years thereafter.**
  
- 2 **Business Corporations** inclusive of domestic or foreign business, professional or close corporations that register **after April 15<sup>th</sup> must file their first two-year report by April 15 the very next year after registration and every two years thereafter.**
  
- 3 ~~Non-profit corporations inclusive of domestic or foreign corporations that register during any date of a particular year must file a two-year report by June 16<sup>th</sup> the very next year and every two years thereafter.~~
  
- 4 **Limited Liability Companies** inclusive of domestic and foreign, or professional companies that register **during any date of a particular year must file the first two-year report by June 16<sup>th</sup> the very next year and every two years thereafter.**

Two-year report form is available on-line by accessing agency's website and clicking on "Corporate Registration" link. Please, make check (s) payable to D.C. Treasurer and be sure to keep a copy of the report.
